4. I understand that by selecting a new sponsor, I will lose any down lines and case credits I have in my current line.
5. I also accept that if the information given by me in this form is incorrect and or incomplete, the management will have the right to reject this request.

Rules and Regulations:

- A Novus Customer, who has been sponsored for six full months and has not achieved the level of Assistant Supervisor during this time, will be eligible to select **a new Sponsor. The sponsor change will happen in the month, immediately after completion of these 6 months.**
- Novus Customers who select a new Sponsor will **lose any former downlines and accumulated case credits.**
- Once your request has been processed, you will continue to use your same ID number under your new sponsor.
- Proxy orders placed by any Forever Business Owner (FBO) for any other Novus Customer becoming eligible for new sponsor request may be disallowed or not counted if it comes to light before the change has been made.
- If your signature on this form is not matching your sign on your FBO application on record, your New Sponsor Request Form will automatically be rejected.
- Once this request is received by the Head Office in Mumbai, the ID will be marked as “in-active” until the final decision has been arrived at. This means that the Novus Customer applying for change of sponsor may not be able to make any further purchases or sponsor any new FBOs until intimated by the management.
- The application for change of sponsor may take approximately 4 weeks to process.
- In the event that multiple IDs are found in the system, the multiple application case will first be resolved before processing the New Sponsor Request.
- If you have become an ASSISTANT SUPERVISOR in the marketing plan purely on the virtue of the sales of your downlines, you will not be eligible for sponsor change.
- It is mandatory to submit a self attested Identity & Age Proof alongwith this form.
- New Sponsor Request Forms accepted on or after 25th of the month will be processed in the following month.
- **In case any of the above mentioned criteria is not fulfilled your New Sponsor Change form may get rejected.**
