2. I have personally attended and received certification at a Company approved certification meeting or by a Company authorized representative.
3. This application shall constitute a binding agreement between Forever Living Products (M) Sdn Bhd (FLP) and myself at such time as this application is received and approved by FLP local Head Office in Kuala Lumpur. 6. I have read FLP's "Company Policies" which are published and available at www.forever.net.my. I understand that my acts, or lack of action, which may result in a misuse, misrepresentation or violation of such policies and procedures can cause the termination of my distributorship by the Company, including but not limited to, use of unauthorized promotional material.

If I should elect to cancel, all products which I purchased from FLP during the previous 6 months and which are in my possession in a resalable condition, shall be repurchased in accordance with FLP's policies and procedures.
