2. I/We have personally attended and received certification at a company approved certification meeting prior to setting company products.
3. This application shall constitute a binding agreement between myself/ourselves and Forever Living Products, FZE - at such time that this application is received and approved by Forever Living Products' Office in the Dubai Airport Free Zone.
4. I/We am/are an independent Contractor. I/We am/are not an employee, or legal representative of FLP, FZE, for any purpose. I/We recognize that my/our remuneration is based on my/our performance of a supervisory, distributive, selling or soliciting function in the sale or delivery of products and not on the number of hours worked or an element of chance.
5. There is no required minimum investment or minimum inventory requirement. Any purchase shall be in reasonable quantities and received at FLP, FZE, in Dubai Airport Free Zone.
6. I/We have read FLP's "company policies". I/We agree to operate my/our business in accordance with these company policies, procedures, and marketing plan. I/We understand that my/our acts, or lack of action, which may result in a misuse, misrepresentation or violation of such policies and procedures can cause the termination of my/our distributorship by the company.
7. I/We acknowledge that FLP, FZE may, after reasonable notice, change, amend or modify this agreement and its policies, procedures and marketing plan to maintain a viable marketing system, comply with legal requirement and changes in economic condition, and I/We shall operate my/our business in accordance with any such change, amendment or modification.
8. I/We agree to properly represent the Company Product, and its marketing plan. All forms of advertising, including, but not limited to audio, and visual tapes and printed material, must be submitted and approved in writing by an authorized company representative prior to use.
9. I/W understand that all purchase orders must be accompanied by cash or credit card payment.
10. **I/WE MAY CANCEL THIS AGREEMENT AT ANY TIME EFFECTIVE UPON MAILING WRITTEN NOTICE TO FLP, FZE.** If I/we should elect to cancel, all products, which I/We purchased from FLP, FZE and which are in my/our possession in a re-saleable condition shall be repurchased in accordance with FLP's company policies and procedures. For this purpose, all products held by me/us for more than 180 days from date of purchase shall be considered not be in re-saleable condition.
11. I/We understand that FLP will make its products available to me/us as a distributor and credit my/our sales efforts as set forth in the FLP Marketing Plan.
12. As long as I/We am/are a distributor and not in violation of this agreement, FLP shall pay me/us for my/our successful sales efforts in accordance with the various bonuses established by the FLP Marketing Plan.
13. I/We agree that this agreement is personal in nature and cannot be assigned or transferred, except in the event of my/our death, wherein the same may be inherited by an individual who can qualify as a distributor.
14. All disputes between the distributor and FLP, FZE shall be governed by Arizona law and resolved by binding arbitration in accordance with FLP's dispute resolution policy. Maricopa County, Arizona shall be deemed the sole appropriate place for jurisdiction and venue of any dispute between FLP, FZE and the independent distributor.
